## RELEASE OF LIABILITY AND ASSUMPTION OF RISKS

The undersigned individual wishes to be a member of the Fin, Feather and Fur Conservation Society, Inc. ("3F Club") and to (1) use the 3F Club's facilities, including but not limited to the use of the grounds, clubhouse, pavilion, rifle range, pistol range, skeet fields, hunting fields, ponds, and all roads and parking areas, located at 904 Swann Rd, Youngstown NY 14174 (the "Facilities"); and (2) participate in the 3F Club programs, including but not limited to skeet leagues, archery leagues, and pheasant programs ("Programs"); and (3) participate in 3F Club sponsored events including but not limited to parties, special functions, picnics, and tournaments ("Events").

1. In consideration for the 3F Club permitting me to use the Facilities, and/or participate in Programs and/or Events, I have agreed to execute this Release of Liability and Assumption of Risks (the 'Release'). I hereby acknowledge, accept and agree that the use of the Facilities and/or participation Programs and/or Events involves inherent risks. I received full information regarding the Facilities, Programs and/or Events and had the opportunity to ask any questions that I wished. I have examined the Facilities, and have full knowledge of the nature and extent of all the risks associated with a gun range, skeet field, hunting grounds, ponds, and roads and parking areas, including, but not limited to serious bodily injury, permanent disability, paralysis, and death. I also agree to release and discharge the 3F Club and all of its respective members, managers, officers, employees, agents and representatives, as well as all other related persons, corporations or other entities that might have any liability to me (collectively, the "Released Parties"), from and against any and all damages, actions, claims and liabilities, whether known or unknown, anticipated or unanticipated, suspected or unsuspected, relating to or arising from any activity, occurrence or event involving the Facilities, Programs or Events wherever or however it may occur. This Release is intended to release and discharge the Released Parties from all damages, actions, claims and liabilities of any nature, specifically including, but not limited to, damages, actions, claims and liabilities arising from or related to the negligence of the Released Parties. I further agree to indemnify, hold harmless and defend the Released Parties from and against any loss, damage, liability and expense, including costs and attorneys' fees, incurred by the Released Parties as a result of my using the Facilities or participating in any Program or Event. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives, if I am deceased.
2. I understand that the 3F Club will not be responsible for any medical costs associate with an injury I may sustain while on the property, using the Facilities or participating in any Program or Event.
3. I further agree to become familiar with the rules and regulations of the 3F Club.
4. I also understand I am responsible for any damage I cause the property or facilities.

5. The laws of the State of New York shall govern the rights and obligations of the parties to this Release and the interpretation, construction and enforceability thereof. I agree that any lawsuit brought against any Released Parties shall be brought solely in the New York State Supreme Court. I acknowledge that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New York and that if any portion of this Release is held invalid, the balance shall, notwithstanding, continue in full legal force and effect.
